

**SUMMARY ANNUAL REPORT FOR  
NORTHWESTERN UNIVERSITY EMPLOYEE WELFARE BENEFIT PLAN**

This is a summary of the annual report of the Northwestern University Employee Welfare Benefit Plan (Employer Identification Number 36-2167817, Plan Number 575) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Northwestern University has committed itself to pay certain medical expense reimbursement and employee assistance program claims incurred under the terms of the plan.

**Insurance Information**

The plan has insurance contracts with Health Care Service Corporation, Cigna Health and Life Insurance Company, Dearborn Life Insurance Company, Hartford Life and Accident, The Guardian Life Insurance Company of America, Combined Insurance Company of America, Four Ever Life Ins Co, and Symetra Life Insurance Company to pay certain health, prescription drug, dental, vision, life insurance, accidental death & dismemberment, long-term disability, and business travel accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$19,440,979.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$10,173,764 as of the end of plan year, compared to \$27,402,888 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$17,229,124. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$149,974,489 including employer contributions of \$106,122,011, employee contributions of \$43,669,877, and earnings from investments of \$182,601. Plan expenses were \$167,203,613. These expenses included \$7,334,482 in administrative expenses, and \$159,869,131 in benefits paid to participants and beneficiaries and to insurance carriers for the provision of benefits.

1. An accountant's report.
2. Financial information and information on payments to service providers.
3. Assets held for investment.
4. Transactions in excess of 5 percent of the plan assets.
5. Insurance information, including sales commissions paid by insurance carriers.
6. Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

**Paperwork Reduction Act Statement**
