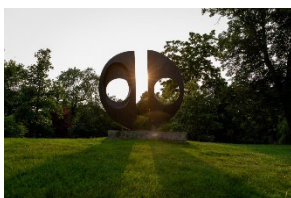

W-2 Forms Coming Soon

It's that time of year! W-2 forms for tax year 2025 are almost ready and will be available for download in myHR by Friday, January 30. If you opted to receive an electronic-only W-2, your form will only be available in myHR. If you did not opt for electronic-only, you can still download a copy from myHR, and a paper copy will be mailed to your home address.

Reminder: New Timesheet Submission Deadlines

The Workforce Timesheet Entry and Approval deadlines are changing for exempt staff and their supervisors starting with the January 2026 pay period. Here's what is changing! Exempt staff will need to submit their monthly timesheets earlier, by 5:00 p.m., on the last business day of each month, and supervisors will need to approve the timesheets by 1:00 p.m. on the second business day of the following month.
