#### **Required Mandated Reporter Training**

University employees received an email from administration@northwestern.edu on June 9, 2025, regarding training to be completed within 90 days. Per Illinois regulation, all Northwestern employees are considered mandated reporters required to report child abuse or child neglect and must complete mandated reporter training every three years. The training course takes approximately 40-45 minutes and is available in myHR Learn under Protecting Children Training Course. Visit the Youth on Campus website for more information.

#### **Northwestern Benefits Update**

Northwestern will transition to new medical, dental and prescription insurance providers for benefits-eligible employees beginning Jan. 1, 2026. Certain terms of the tuition benefits are also changing. Because of the scope of the changes, all benefitseligible employees who want healthcare coverage beginning Jan. 1, 2026, will need to take action during the Open Enrollment period in the fall. #### **Retirement Plans Age 60-63 Catch-up**

The SECURE 2.0 Act allows retirement plan sponsors to adopt higher contribution catch-up limits for ages 60-63 starting in 2025. Effective July 1, 2025, the Northwestern 403(b) retirement plans allow eligible employees ages 60 to 63 to contribute up to the higher catch-up limit of \$11,250 over the regular IRS contribution limit of \$23,500.

Note: The age 60-63 increased catch-up applies only to those who turn 60, 61, 62, or 63 during the calendar year (for 2025, birth years 1962 through 1965). Learn more about Making Changes to Contribution Amounts & Investments.
